## New way of doing business at SCA

The Southampton Citizens Association (SCA) is pleased to report that substantive changes have been proposed for the governing Articles of Incorporation and Bylaws.

SCA for a couple of years has deliberated on and drafted varying changes to the organization’s Articles of Incorporation and Bylaws. A first draft was only partly adopted last October so this year a new team went about making changes. Now, a new draft will be evaluated and considered at the **Annual Meeting on October 16**. All members will be eligible to vote on the changes but to vote will require that dues be paid. Among the biggest change, clarifying that members have a right to vote on all substantive issues before SCA. The documents will be disseminated electronically and also available at the September meeting.
